#12 Call to Order

The meeting was called to order at 7:00 p.m.

Dr. Dan Kingsbury – The Jellyfish Project

Dr. Kingsbury provided the audience with the background of the Jellyfish Project and the proposal to have School District 46 (Sunshine Coast) and School District No. 44 (North Vancouver) pilot a program, which will offer the project as part of the curriculum for grade 4 and grade 11 students.
